SUBJECT TO THE EXCLUSIONS FROM COVERAGE, THE EXCEPTIONS FROM COVERAGE CONTAINED IN SCHEDULE B AND THE CONDITIONS, First National Title Insurance Company, a Texas corporation (the "Company") insures, as of Date of Policy and, to the extent stated in Covered Risks 9 and 10, after Date of Policy, against loss or damage, not exceeding the Amount of Insurance, sustained or incurred by the Insured by reason of:

- Title being vested other than as stated in Schedule A.
- Any defect in or lien or encumbrance on the Title. This Covered Risk includes but is not limited to insurance against loss from:
 - A defect in the Title caused by:
 - forgery, fraud, undue influence, duress, incompetency, incapacity or impersonation;
 - failure of any person or Entity to have authorized a transfer or conveyance;
 - a document affecting Title not properly created, executed, witnessed, sealed, acknowledged, notarized or delivered;
 - failure to perform those acts necessary to create a document by electronic means authorized by law.
